I would like the Board to decide on the youth Top Ten awards at this meeting. This will hopefully allow us to plan to save on shipping costs if we do signs or something similar that needs to be shipped.

Discussion ensued concerning this request and various options offered. The decision was unanimous that Becci would confirm if the cost would be similar to last year's and also find out the additional cost if similar awards were made to youth achieving the High Point designation.

I have found some issues with the database that I will address at the meeting. It has slowed up show results input a bit but thankfully this is a slow time. Work on a solution is currently being undertaken.

Just a reminder that non-members are allowed one free ALSA show a year. I am keeping track of this and will enforce it this year. So, shows need to do their due diligence in making sure who are members, who is using their one free show and who needs to pay a non-member fee. If those of you who run shows can start doing this, it will help on my end. I will also be encouraging shows to send in their results in a timelier manner, with the hope that we can wrap things up by the end of the year for 2024.

The website is coming along. The developers are wrapping up some of the final design elements. So hopefully soon we will have a preview.

Top items of discussion:

2023 ribbons were all new. Total of 770 ribbons for \$3400. This year we need to order 250 less ribbons for a savings of \$1200.

200 Fiber ribbons were purchased new.

This year need 70, for a savings of \$300.

\$1300 for 2023 banners, same is expected for 2024.

Would like to use the banners again this year. Lots of compliments on being easy to transport, take to other shows, easy to clean and great in photos.

Banquet was \$1200 for 120 people.

Service was wonderful and everyone loved the food.. Would like to use this caterer again for 2024.

Tables and chairs were \$500. Company was wonderful and would use them again in 2024.

Photo back drop and photo sign purchased new for 2023 and had great comments and lots of photos were taken. Will use these again for many years to come.

Projected savings is \$1500 in ribbons.

Saving of \$300 for photo back drop.

Discussion about alpaca halter:

Total of 8 alpacas competed.

Judge was paid \$350.

The only banners that were not awarded were alpaca banners.

How can we fix this?

Can we do alpaca halter at another time? To avoid the \$350? Can we offer a lesser amount for the hour for Sunday? Thoughts on this please

The Board discussed the lack of participation at Grand National Shows by owners of alpacas. Suggestions as to how to motivate alpaca members to take part in the national show were made. It may be the solution is to use a qualified llama Judge to oversee the alpaca portion of the show as a cost-savings measure if alpaca participation does not improve.

Cathie is signing a contract for Oct 5/6 at the Kirkwood again this year. Price of stalls has gone up so we will need to raise fees on that, other. se I think we stay with same entry fees.

Nationals judges are Cathie Kindler, Lauren Wright, and Trish Schneeburger.

Fiber /alpaca just has not been chosen.

Holly and Kari did a fabulous job doing obstacles again and would like to hire them again.

Catherine Steel was amazing as always and want her for my clerking again.
