As Superintendent of the Allen County Open Llama Show, I am aware of the ALSA Waiver of Youth Membership Fees for one ALSA Show Per Year, approved at your meeting May 12, 2021. I agree with the BOD's thoughts that this will improve attendance and promote ALSA sanctioning from a Superintendent's point of view. I would like to request a Marketing strategy one step further for my show only as a test. Waive the Non-ALSA Member fee for all exhibiters. This fee is the primary reason I have chosen in the past to dual sanction as a double ILR show rather than have ALSA sanctioning. I received many calls from exhibitors wanting to participate only in the ILR sanctioned part of the show due to the fee, then deciding not to participate at all when they realized the only cost savings to them was that fee. I would like to continue to support ALSA with my show. I would be glad to highlight this Waiver as a benefit of my show and be clear during my exhibitors meeting that this was a one-time only and only for this show. If you feel it is successful in increasing my show attendance sufficiently, I feel this would give you another benefit to sanctioning shows that are having trouble encouraging attendance.
