## Special Report Report and discussion concerning 2024 ALSA Grand National Show

## I. Office Report:

Becci Kunkel Executive Secretary, ALSA Office We ended the year with:

170 Adult Memberships - We had a lot renew for 2025 already. I am getting 2025 set-up and will be sending out cards this week. Years ago, the office would send a letter with the membership cards that would thank them for being members and have the benefits of being an ALSA member. I will start emailing the letter with the cards. I'll send copies of the letters to the board before the meeting.

134 Youth Memberships - this includes the 3 lifetime members.

46 sanctioned shows for the year - this is down from last year.

So far, we have one show sanctioned for 2025 plus more that have sent in their paperwork, just waiting on payment.

I emailed a list of questions to IDS about the database:

The old site has a secured link to view show results, this needs to be unsecured. We need to have the tables added back in to access so that members can go back to searching their animal's results on a year-by-year basis.

Fix the Adult Showmanship ROM issue and separate them from the animal ROMS. There are multiple error messages within the database that I'm not sure how to fix. Is there a way to get a notification on new youth and animals that receive awards? Cleaning up the Alpaca Classes and adding new ones.

Cleaning up the formatting for the show results, master and alpaca classes are mixed together and getting all the halter classes together.

Adding in a yearly top ten for animals too - **This is a question that was proposed to** *me, not sure if the board wants to pursue this, but I figured we can see what it would cost.* 

All the performance divisions and halter divisions.

In putting in the Great Lakes Regional I also realized that we do not have Classic Classes in the database connected to the website. I can see them in show results, but they do not show up on the website, so they need to be added in. Right now, I'm adding them as a COMBINED HALTER CLASS. That way I can easily find them and fix them whenever we get this issue taken care of.

I am talking with IDS about having a link to upload results from the website, there are a few issues that I will address on the call and see if we can figure something out.

Youth Top Ten awards - I am reaching out to shows to see if we can get results sooner. Most have submitted results, the ones I'm waiting on have been the ones I've had issues within the past. I need a board decision on awards. The board voted on having the pvc signs again as the Youth Top Ten awards.

I spoke with the youth scholarship chair this past weekend. We will start reminding everyone about the youth scholarship deadline, March 15th, and putting it on Facebook and constant contact. The youth scholarship committee proposed a tiered scholarship moving forward. If 1-5 applicants, then \$1,000 will be awarded to one youth. For 6 + applicants then there would be 2 scholarships awarded in the amount of \$750 each. Denise motioned to change the scholarship to a tiered scholarship with the aforementioned numbers and amounts. Ana seconded the motion. The board unanimously voted on the tiered scholarship and an increase in amount.
