I. Office Report

The Youth Top Ten is mostly finalized. I am doing a final check and then signs should be printed this next week and I'll finishing the certificates. I am waiting on a meeting with a sponsor about an additional award we had discussed at an earlier meeting. With it being a large company, I am not sure how fast they will move and if this would be possible for this year.

Handbooks have been mailed out to everyone that ordered them. I have additional handbooks for any new judges/apprentices or anyone else that orders one.

All shows results submitted to me have been uploaded to the database. They are not on the website since the new website should be going live soon.

We have 33 ALSA sanctioned shows, including Nationals and two Regionals. Four shows are new to ALSA.

I'm still working on 2021 shows. With everything going on with Noah, I had to delay working on them but am back at it and trying to get them finalized asap.

For 2023, I am down to three shows left to finalize. For two, I'm just waiting on payment but have been in contact and talked with both shows. The third show is the one I have been having issues with. (Phone calls just go to answering and no responses are received. The superintendent will be informed of possible sanctions if the issues are not quickly resolved.) I have received partial results but no others, no show recap, and no payment. (A day after this meeting, the show superintendent conveyed the 2023 show results and fees to the ALSA office.)

Motion: Pay Becci's office expenses of \$1,770.00 for March. Motion by Ron. Seconded by Anna. Motion unanimously passed.

II. Treasurer's Report:

Vern reported the following financial information:

Revenues are a bit behind last year at this time. This is due to a combination of factors: some Judges prepaid their 2024 Judges' dues, and a number of members paid their 2024 dues in 2023. All told, progress is evident. A refund is being obtained from QuickBooks as ALSA has not been able to implement some features of it.

A suggestion was made that we should look into moving our savings accounts from low-paying bank savings accounts into certificates of deposit to earn more monies from their investment. Vern said he would follow up on this suggestion and report back on it to the Board. Additional financial information is presented at the end of this report.

The Judges' Committee brought the idea of a dual ALSA-ILR fleece clinic in Washington state organized by Amanda Wick and taught by Fran Soukup to the Board and asked it to be approved. Discussion was by email and the following Motion subsequently offered:

Motion passed by email vote:

Motion: Approve the proposal of a joint ALSA-ILR fleece clinic to be held in Washington state and taught by Fran Soukup and organized by Amanda Wick. Motion by Anna. Seconded by Lauren. Motion Unanimously passed.

Denise brought to the Board a request from the clinic for a \$250.00 donation to help defray clinic costs. After some discussion, the following Motion was offered:

Motion: Donate \$250.00 towards the expenses of The joint ALSA-ILR fleece clinic. Motion by Ron. Seconded by Denis. Motion Unanimously passed.

Grand National - Chair: Susan Leslie, Liaison: Holly

Holly has asked that the following items be discussed at this Board meeting:

•Approval to add a classic/light wool division in Ilama halter.

There ensued considerable discussion about the merits of implementing this division at the Grand National Show. One of the situations that is occurring is participants entering llamas

in classes other than what their wool really is to place higher than they otherwise would. Institution of a different division system would alleviate this as well as give animals an opportunity to compete against similar animals.

A decision was therefore made as follows:

Motion: At the Grand National Show add a classic llama division that is separate and distinct from light wool. Motion by Denise. Seconded by Anna. Motion unanimously passed.

•Decision on not having alpaca halter and just doing alpaca performance. Last year there were very few entries in halter. That has been the trend for the past few years.

This also was discussed at some depth. The fact is sometimes only one or several alpacas are presented in classes. This creates expense in several ways, not only the cost of engaging a qualified alpaca Judge to judge very few animals but also expenses related to awards. Why more exhibitors do not enter alpacas at the show is unknown but has created the current situation. As a result of this discussion, the following Motion was adopted on a roll call vote:

Motion: Remove alpacas from the 2024 Grand National Show due to lack of participation. Review and reconsider this decision for the 2025 Grand National Show. Motion by Tim. Seconded by Anna. Motion passed.
