I. Office Report:

Becci Kunkel Executive Secretary, ALSA Office

We have 6 shows sanctioned for 2025 - plus some sent to me early last year that I need to get back to for payment.

I am trying to get 2024 shows wrapped up. I'm still having issues with a few summer shows that still have not submitted results or payments. I'm not uploading their results until I have received payment.

My goal is to have all the shows uploaded and Top Ten announced in January. It would be great if we could have the awards ready in March and then delivered to shows to save costs on shipping.

I have had a connection issue with access/database, as when I am in the database working it will frequently kick me out. It has slowed down my uploading results. IDS thinks it's an issue in host gators end and with something within the database. They feel like it's something that's become outdated and just needs to be updated but are looking into it. I am still hoping to have 2020 shows corrected by the end of the year, even with the connection issue.

IDS and I have had a few conversations about the database. An estimate is a bit difficult because there are so many issues that need fixed or updated. I am including the items that need to be addressed for the new Board members.

- Adding Classic Classes back into the database
- The old site has a secure link to view show results, this needs to be unsecured
- We need to have the tables added back in to access so that members can go back to searching for their animals' results on a year-by-year basis
- Fix the Adult Showmanship ROM issue and separate them from the animal ROMS
- There are multiple error messages within the database that I'm not sure how to fix
- Is there a way to get a notification on new youth and animals that receive awards
- Cleaning up the Alpaca Classes and adding new ones

- Cleaning up the formatting for the show results, master and alpaca classes are mixed together and getting all the halter classes together
- Adding in a yearly top ten for animals too

The Ethics and Protest committee met 12/05/2024 via Zoom to discuss case 20241122.

The review included the actions of accused as seen by multiple witnesses and screen shots of social media.

The potential infraction(s) were compared to the Rules as stated in the 2024 ALSA Handbook and Guidelines. The actions of the accused were found to be in violation of three guidelines in two Parts of the Handbook by unanimous decision of the roll call vote taken of the four committee members and the committee chair.

All efforts of the committee were approached by all to be sensitive to the accused's right of free speech, right to have an opinion that may be opposed to others' opinions and his right of free choice to act on his opinion to participate in any activity.

The committee Chairman is drafting an official report to the BOD with a recommendation of penalty.

Halter ring ran smoothly on Sunday. Judges were all excellent and easy to work with, exhibitors had a good time, no complaints were received. Many volunteers stepped up to help thru out the weekend and were greatly appreciated.

Committee is recommending a 6-month suspension due to history of knowledge of rules in violation and warning in 3/2024. Part V. Sec 2. A. 3 penalties, B and G

All results be removed and updated, and all awards and prize money be returned and forwarded to rightful exhibitors.

Committee also is recommending for any above a 60 day grace period to return awards and prize money to ALSA office before a letter of not in good standing be issued for any above having earned awards.

The committee is unanimously in agreement that if in adjusting the show results to reflect the removal of llama in violation, never will we ever ask for a grand or reserve award be returned unless it is being upgraded from a reserve to a grand and we have said award in hand in ALSA office to send to them

The performance committee unanimously agreed to all above warnings, suspensions and award revocations. Please feel free to reach out to me on behalf of the committee with any questions you have.

If these placings placed you over the limit of 4 qualifying wins, there is no consequence to you, as this was a situation out of your control.
- 3.) We will forward you any awards or prize money collected; we have also included a novice reference chart for your convenience. Please contact the ALSA office with any questions you may have.

No information was provided the Board as to the names, shows, or animals that were believed involved in the above violations.

There ensued an extremely lengthy discussion concerning these violations, whether members knowingly or unknowingly committed them. Each was reviewed as to the person involved, the particular show, and the severity of the violation. In one case, it was pointed out that the violator had consistently disregarded the Handbook requirements for entering animals in the correct class despite receiving warnings, advice, and mentoring.

Some history as to how similar situations were managed in the past, and how the results of such affect ALSA were discussed and debated. Suggestions were made as to what would be for the good of ALSA moving forward. Several roll call votes on possible Motions were made and the final Motion was as follows:

Motion: The Ethics Committee should send a letter to each of the above-involved members delineating their violations and recommend they follow the Handbook in making future entries. All awards, ribbons and any prize money received from these incorrect entries are to be returned to the ALSA Office. Motion by Tim. Seconded by Denise. On a roll call vote In favor of the Motion: Denise, Tim, Ron, Lauren (by proxy) Opposed: Holly, Abstained: Anna the Motion passed.
