Hopefull our list will include many more experienced judges than in the last couple of years. The best judes should be hired to judge the Grand National and Regionals.

The Grand National Committee has discussed the pros and cons on the suggestion of a "Classic Llama Class". Our feelings about this addition led to a list of concerns. We believe that adding a class this year should entail continuing this class in the future years. Although the offer of Trish's sponsorship is greatly appreciated the amount of premiums being more in any one class would not be fair. Premiums should be the same across the board. I think all of the Board knows our thoughts on the collection of sponsorships. If someone designates their donation go for a specific purpose, such as premiums, that's where it should go. In this regard, soliciting money for the Classics would not be fair to the donor to apply it elsewhere.

This leads to the matter of future Grand Nationals. We might have the sponsorships for this year but what about the future? If this is a onetime donation it will seriously dip into the premium monies and be a deficit for ALSA in the upcoming years.

The committee has contacted several members that have Classics to get a definitive description. The one constant in this survey was that the fiber is different. Because the halter classes at an ALSA show are not to be judged on fiber but on conformation, does this class really differ greatly from the Light Wool Class?

Just a suggestion from the committee - how would it work if we added a fiber class for the Classics and left them showing in a Light Wool class? Once again, the premium money collected would have to be distributed equally in the fiber classes. It would keep our payout for halter classes the same but offer more in the fiber division and give the members a way of showcasing their Classics.

ALSA handbook changes approved by the Board in 2011 have been completed through recently posted December 1, 2011, board minutes and ALSA office contact information change. I had anticipated making any additional handbook edits resulting from the December 13, 2011, board meeting and submit to committee for finalization to close out this year's handbook revision; however, those meeting minutes have not been posted for inclusion into the handbook.

As I previously mentioned to Ken Forster, I was experiencing trouble with my Adobe InDesign CS2 program I have used over the past four years for updating the ALSA Handbook. I did receive Adobe InDesign CS4 software used by another ALSA committee from the ALSA office this month. I did not attempt to use this software because of a possible unauthorized user conflict as described in accompanying software documentation.

I was able to convert the ALSA Handbook 17th Edition work version due out to the membership in time for the start of the new show season this January to an editable Microsoft PC word program. Any future handbook changes needed to be made can be accomplished in this format. I have mailed a CD copy of this text to Ken with the above Adobe software for his attention.

I had intended to wait until all 2011 amendments were included in this handbook before final page, table of contents and index formatting was done and then reviewed by Handbook Committee for final proofing. We are at the close of 2011 and, because of upcoming family and other personal commitments, any additional handbook revisions completed on my part at this late date in the year would not be possible within any certain time period. Consequently, I am going to discontinue my participation on the Handbook Committee upon submission of this report.

Regional Championship Committee Report for February 7, 2012 Board Meeting

1. It has been confirmed that all 2011 Regional Championship judges' fees and expenses have been paid.

- 2. From the results published in Showring and communications with judges, volunteers and exhibitors it has been possible to calculate entry fees, sponsorships, expenses and premiums paid in the Buckeye and Great Lakes Regions. The attached revised spreadsheet shows that those two shows basically broke even and that the overall net profit from the 2011 Regional Championships was \$4,502.05. The bottom line would have been better if the superintendent of the Southeastern Regional Championship had not spent more than \$2,000 on a catered dinner. Exhibitors' dinners at the other Regional Championships were either potlucks or paid for by sponsors and did not cost the ALSA membership any money. The Southeastern superintendent represented to exhibitors that the dinner was being paid for by sponsors, and it appears there was actually enough sponsorship money to cover the premiums paid to exhibitors and also pay for part of the dinner. However, it appears that about \$1,517.00 from entry fees that should have been sent to the ALSA office was used to pay for the dinner instead. No receipts or other proof of expenses were provided, so it is impossible to tell exactly how the missing funds were spent.
- 3. In spite of the questionable use of ALSA funds by the Southeastern regional superintendent, we hope that the Board will consider the proposal to make the Regional Championships break-even events with any net profits left after expenses to be used for premiums for the exhibitors. If so, we will develop a plan for the mechanics of how this will work while also providing safeguards to help prevent future misappropriations of ALSA funds.
 - #3 BOD sent back for further clarification and details.
- 4. Request approval of Barb Harris to again serve as superintendent of the Rocky Mountain Regional Championship to be held in conjunction with the LOCC Fall Show on Labor Day weekend with the same cost-sharing arrangement as in previous years.
- 5. Request approval of Jim Doyle to again serve as superintendent of the Central Regional Championship to be held in conjunction with the Oklahoma City State Fair with the same cost-sharing arrangement as last year.
- 6. The committee chair has been informed that the Hoosier Llama Alpaca Association has volunteered to host the Buckeye Regional Championship to be held in conjunction with its Fall Show on September 22 & 23 in Noblesville, Indiana, but the superintendent has not yet been identified. When the superintendent has been identified we will obtain more details and hopefully be able to submit a proposal to the Board in the very near future.

A. Wool Division Descriptions

- 1. Classic Wool:
 - a. Double coat with prominent, abundant guard hair throughout coat.
 - b. On the body (except juveniles and yearlings), undercoat has moderate to sparse density and is either minimally or not at all visible under the guard hair.
 - c. Very short smooth fiber on face, ears, forehead and head.
 - d. Short leg fiber above the knee or hock and short smooth or minimally ruffled hair below the knee or hock.
 - e. A large "window" of short, smooth hair on either side of their sternum.
 - f. Neck fiber that often sheds out leaving a discernible guard hair "mane".
- 2. Suri Wool: Suri llama have a natural balanced, athletic type which may appear more narrow than llamas of other fiber types when viewed from the front or rear aspect. The fiber of a Suri Llama should have a natural luster and hang and drape over the llamas body, usually forming a natural part along the spine. The fibers are grouped into a very distinctive and well defined lock structure, which is indicated by the many individual separate locks of fiber formed at the skin and carrying out to the ends of each lock. The fiber should be lustrous, the locks independent and consistent in size, and the degree of wave or spiral content throughout the neck and body. The fiber is also characterized by absence of crimp and minimal loft.
- 3. Light Wool: Minimal body wool, short neck wool with smooth legs.

- **4.** Medium Wool: Moderate to long body wool, minimal to moderate neck wool, smooth to moderate leg wool.
- 5. Heavy Wool: Abundant body and neck wool with minimal to abundant leg wool (i.e. leg wool at least to knee and hock).
- 6. Combined Division: Any combination of the above divisions.

At this time the Judges' Committee would like to present to the board a proposal that is more in line with the original complaints that were filled.

We support the board's decision in the suspension of Ms Kindler but would like to request that board reevaluate the requirement as posted in the minutes dated June 14, 2011 that Ms Kindler be required to attend an Advanced Judging Clinic. The committee did not feel at the time of our report that Ms Kindler's performance as a judge was in question but her demeanor as an instructor was our concern.

I will try to answer these comments in the order that they were presented.

First, the National Committee has not chosen the fiber judges - that has always been taken care of by the fiber committee. We are not asked by this committee if we approve but simply told who they are. The fiber committee has always acted separately from the National Committee by ordering their own ribbons, chosen judges, kept their financials separate, etc.

The scheduling situation being brought to our attention is a real sore spot with the National Committee. If you will remember, Ken, when we had the committee meeting with the fiber committee as they requested, it was basically mandated to us that they wanted to cut off the entries (no late entries) and we were totally opposed. They are right - it did cut down on entries. It took away many entries from both the fiber and the versatility classes. They are the ones that requested the time for the presentation. Again, not our decision. Is this once again something that the Committee takes the blame for when it was not our decision?

If the fiber committee had truly taken notice as they said, that "everything was through and everyone was out of the barns", they would have been quite surprised that the performance courses ran on until "late" in the afternoon or I should say evening. We have tentatively set the fiber presentation for 8:00 Sunday morning before both rings have started their competitions. They will get their "own time" as they have requested. The Committee has decided that there will NOT be a cut off for late entries as there was last year. It is extremely difficult for the fiber entries to meet their deadlines. As for judging on Thursday - they could not seem to understand that many exhibitors do not arrive until the wee hours of Thursday and Friday morning. They are busy setting up and getting ready for classes that start early Friday morning. Our decision making is based on what will benefit all of the exhibitors the most.

To the matter of Supers getting paid? If the BOD in fact wants to go strictly by the handbook fine. As you may recall when the Grand National Committee had the meeting with the BOD it was brought up. I can say as being the Grand National Supt., I have not been paid a thin dime. I am supplied a hotel room and that's it. Malcolm and I have never requested to be reimbursed for our expenses. If it is in the handbook and that is what is decided, I will be glad to turn in all of my expenses, i.e., gas, meals, out of pocket expenses (as all three of us have done for several years) etc. (We have graciously taken this upon ourselves so that we can save ALSA money. Do they realize that we spend an entire year to make this better and come up with new ideas? This is NOT a one weekend endeavor.

If a fiber person wants to be on the National Committee, do they realize that by becoming a member of this team that they will be expected to work in other areas besides fiber? Our committee wears many different hats throughout the year and at the Show itself. They would be expected to assume other responsibilities and there are many. The Committee spends a day and a half (after we get there on Tuesday night) simply sorting the ribbons. The trophies must be unpacked and placed in order by classes and make sure they are in the arena at the correct time. There are many office duties before the actual show that must be performed. I could go on and on but as so many things are taken care of as they arise it would be difficult.

Judges' Committee Report May 2012

The committee has been reviewing requirements for an ALSA judge to become an ALSA instructor. Reviewing previous handbooks and guidelines it has come to our attention that key wording has been lost over time regarding the criteria for an ALSA judge to become an instructor. The following is the current wording as it appears in the 17th Edition.

C. The Judges' Committee makes recommendations to the Board of Directors for instructors, assistant instructors and apprentice instructors.

1. An instructor must be a member in good standing, a licensed Llama or Alpaca Judge and have prior instructor experience. To be placed on the recommendation list, an Instructor must first successfully complete at least two (2) approved ALSA Judging Clinics as an Assistant Instructor with a favorable evaluation from the Instructor. All instruction materials must be approved by the Judges' Committee.

During the tenure of Virginia Christensen as the chair of the Judges' Committee the current chair had discussions with her as to the requirements for a judge to become an instructor. This was in relationship to the current Judges' Committee chair's position as chair of the Education Committee. It was covered at that time that a Level 3 judge needed to complete at least two (2) Assistant Instructor positions in their chosen discipline (i.e. Ilama halter/performance, alpaca halter performance, Ilama fleece or alpaca fleece). As the wording stands at this time a fleece judge who had completed two assistant instructorships with favorable reviews could at this time also apply for a position as a llama or alpaca halter/performance judge.

Therefore we would like the following change to the above paragraph:

, an Instructor must first successfully complete at least two (2) approved ALSA Judging Clinics as an Assistant Instructor, in their chosen discipline, with a favorable evaluation from

In addition we would like to make a correction to the following wording in the opening line:

1. An instructor must be a member in good standing, a licensed Llama, Alpaca or Fleece Judge with five (5) years judging experience and have prior instructor experience.

The conversation with Virginia further clarified, back at that time, that the list of instructors available for clinics was only changed if an instructor requested to be removed or due to violations and/or disciplinary actions was removed from said list. It appears that has not been followed and instructors have been left off for reasons unknown.

At this time the committee wishes to propose that the Standard Operating Procedure for maintaining the list of approved ALSA Instructors be as follows:

An ALSA instructors and assistant instructor list will be maintained by the ALSA Judges' Committee based upon the following criteria:

- Completion of requirements to become a certified ALSA Instructor.
- Maintain within the Instructor's Judges file a list of clinics instructed and reviews of said clinics.
- Maintain within the Instructor's Judges file any complaints or disciplinary actions directly related to their position as an instructor.
- Any requests by said instructors to take a leave of absence or retirement.

Using said criteria the ALSA Judges' Committee will at least once a year review the ALSA Instructor and Assistant Instructor list with subsequent recommendations to the Board of Directors.

The ALSA Judges' Committee will at review any complaints of an instructor submitted to this committee and will investigate said complaints. If complaints are validated disciplinary action will be reviewed by the ALSA Judges' Committee and then recommended to the ALSA Board of Directors.

Disciplinary action will be based on the severity of the complaint and could include, but not limited to, any of the following:

- Letter of warning to be placed in said instructors file.
- Suspension as an instructor with the requirement that said instructor will be required to reenter the ALSA Instructors Program and complete all levels of that program satisfactorily.
- Revocation of instructor's certification without possibility of reinstatement as an instructor.

The committee would like to also clarify that all ALSA Judge's files are the property of the ALSA Judges' Committee and will be maintained at all times by said committee.

Page 156 of ALSA Handbook

Section 6. Member in Good Standing

A member in good standing is one who has paid the current membership fee or has a Lifetime membership. A member ceases to be in good standing upon:

- (a) Failure to pay the annual membership fee, or any subscription or indebtedness due to the Association.
- (b) Suspension due to infraction of ALSA rules, or
- (c) Permanent suspension by a two thirds (2/3) vote of the Board of Directors

The Board may cause the name of such member to be removed from the register of members. Such a member may be admitted to the membership by the Board upon their receiving such funds, as they may consider satisfactory.

If she was not on the board at the time of the posting of confidential material then she violated the (Member in Good Standing) rule which makes her ineligible to be a judge.

Below are the opinions for the 2nd submittal of the Ethics Committee.

Recommendation regarding Cathie Kindler

- 1. ALSA Judging license be revoked (Webster Dictionary-to annul by recalling or taking back: repeal, rescind) She does not get it back ever.

Dear ALSA Board of Directors,

The Llama Fleece Committee would like to make the following recommendations:

1. In an effort to clarify confusion regarding points awarded for llama fleece, page 33 of the new handbook (35/188 of the online document toolbar), D. 4 states: There are no points recorded for Champion and Reserve Champion at Halter, Performance Cart Driving, or Fiber. These achievements are recognized under ALSA Champion and Elite Champion Awards. (per Robin Turell at the ALSA Office, "Halter" should not be here. Grand & Reserve Champions in the Halter division are awarded points; Performance divisions are not awarded points). The "Points Chart" (187/188 of the online document toolbar) does not exempt any Champions/Reserve divisions and therefore it could be interpreted that animals earning a Grand and/or Reserve Champion will receive points based upon their division and not just their class. Additionally, Section O, 3, h (pg 100, 102/188 of the online document toolbar) states: Grand Champion and Reserve Grand Champion points will be given in each fiber division, Double, Single and Suri. The champions will be decided by the highest points scored on the fiber score card. In case of a tie, the judge will determine which criteria to use to break the tie. All of that being said, it is our recommendation that ALSA Points are awarded the any Grand and/or Reserve Fiber Champion and that everything should be tabulated as it is for Halter divisions.

- 2. Pursuant to Item 1, we recommend the word "fiber" from page 33 D4 for the 2013 18th Edition of the ALSA Handbook.
- 3. Pursuant to Item 1, we recommend that ALSA eliminate the ALSA Fleece ROM and ALSA Fleece Champion and replace these awards with ALSA Walking Fleece ROM, ALSA Shorn Fleece ROM, ALSA Walking Fleece Champion and ALSA Shorn Fleece Champion (tabulated via the results of each divisions classes). We believe that the addition of separate lifetime fleece championships will encourage participation and add clarity to the ALSA Fleece Championship status.

Other discussion points include:

- 1. Updating the ALSA Fleece Scorecards with the updated ALSA logo and reorganizing the placement of criteria so that "Cleanliness & Preparation" are at the bottom;
- 2. Updating the Llama Fleece Judges Manual so that it is updated for the August 2012 Llama Fleece Judges Clinic;
- 3. Considerations for new scorecards as of January 1, 2013

Judges' Committee Report May 2012

The committee has been reviewing requirements for an ALSA judge to become an ALSA instructor. Reviewing previous handbooks and guidelines it has come to our attention that key wording has been lost over time regarding the criteria for an ALSA judge to become an instructor. The following is the current wording as it appears in the 17th Edition.

C. The Judges' Committee makes recommendations to the Board of Directors for instructors, assistant instructors and apprentice instructors.

1. An instructor must be a member in good standing, a licensed Llama or Alpaca Judge and have prior instructor experience. To be placed on the recommendation list, an Instructor must first successfully complete at least two (2) approved ALSA Judging Clinics as an Assistant Instructor with a favorable evaluation from the Instructor. All instruction materials must be approved by the Judges' Committee.

During the tenure of Virginia Christensen as the chair of the Judges' Committee the current chair had discussions with her as to the requirements for a judge to become an instructor. This was in relationship to

the current Judges' Committee chair's position as chair of the Education Committee. It was covered at that time that a Level 3 judge needed to complete at least two (2) Assistant Instructor positions in their chosen discipline (i.e. Ilama halter/performance, alpaca halter performance, Ilama fleece or alpaca fleece). As the wording stands at this time a fleece judge who had completed two assistant instructorships with favorable reviews could at this time also apply for a position as a Ilama or alpaca halter/performance judge.

Therefore we would like the following change to the above paragraph:

, an Instructor must first successfully complete at least two (2) approved ALSA Judging Clinics as an Assistant Instructor, in their chosen discipline, with a favorable evaluation from the Instructor.

In addition we would like to make a correction to the following wording in the opening line:

1. An instructor must be a member in good standing, a licensed Llama, Alpaca or Fleece Judge with five (5) years judging experience and have prior instructor experience.

The conversation with Virginia further clarified, back at that time, that the list of instructors available for clinics was only changed if an instructor requested to be removed or due to violations and/or disciplinary actions was removed from said list. It appears that has not been followed and instructors have been left off for reasons unknown.

At this time the committee wishes to propose that the Standard Operating Procedure for maintaining the list of approved ALSA Instructors be as follows:

An ALSA instructors and assistant instructor list will be maintained by the ALSA Judges' Committee based upon the following criteria:

- Completion of requirements to become a certified ALSA Instructor.
- Maintain within the Instructor's Judges file a list of clinics instructed and reviews of said clinics.
- Maintain within the Instructor's Judges file any complaints or disciplinary actions directly related to their position as an instructor.
- Any requests by said instructors to take a leave of absence or retirement.

Using said criteria the ALSA Judges' Committee will at least once a year review the ALSA Instructor and Assistant Instructor list with subsequent recommendations to the Board of Directors.

The ALSA Judges' Committee will at review any complaints of an instructor submitted to this committee and will investigate said complaints. If complaints are validated disciplinary action will be reviewed by the ALSA Judges' Committee and then recommended to the ALSA Board of Directors.

Disciplinary action will be based on the severity of the complaint and could include, but not limited to, any of the following:

- Letter of warning to be placed in said instructors file.
- Suspension as an instructor with the requirement that said instructor will be required to reenter the ALSA Instructors Program and complete all levels of that program satisfactorily.
- Revocation of instructor's certification without possibility of reinstatement as an instructor.

The committee would like to also clarify that all ALSA Judge's files are the property of the ALSA Judges' Committee and will be maintained at all times by said committee.

ALSA Judges' Committee Report June 2012

The committee was asked to review two items and provide our thought and input on them.

The first item dealt with a complaint filed against a judge who is currently under suspension. After much deliberation the committee felt this was an ethics issue decided to defer this issue to the Ethics committee.

The second item deals with the following rule as it appears in ALSA Handbook 17th Edition Part U Ethics, Section 4 - Judges:

C. Judge must not have personal contact with exhibitors (other than a brief greeting) until after the entire show is over. Examples of personal contact include but are not limited to: talking to exhibitors outside the ring, riding together, dining together, visiting in the barn, and viewing sale animals or attending llama or alpaca sales in conjunction with the show they are judging.

After discussion we believe that this rule is important. It clarifies what is considered acceptable behavior by a judge. In this era of smaller shows where most judges know many of the exhibitors many times something innocent can be misconstrued which could lead to the questioning of a judge's integrity.

We do want to clarify though that shows that have dinners or potlucks that are available for all the exhibitors to attend may invite their judge(s) to also attend provided the judge(s) is(are) allowed to obtain their food without the presence of exhibitors and are seated in an area which can be secured from any exhibitors who are still showing.

The committee has also submitted a proposal to both the Alpaca Committee and the Fleece Committee to make all ALSA judges equal as in doing away with Level and Senior designations and allowing recertification through CEC credits. This proposal has been suggested so as to remove any possible suggestion that there is discrimination against any of ALSA's judges.

Because this is a major change the Judges' Committee is aware of the need for the Alpaca and Fleece Committees to discuss and decide the best way to possibly adopt such a change. We are open to them for any discussion on this topic and hope that a decision granting equality to all ALSA judges can be put forth for implementation in January 2013.

We would also like to obtain board approval for a Beginners/Advanced Llama Judging clinic with a breeders segment to be hosted by Sally and Jeff Rucker, owners of Stage Stop Llamas. Their ranch is located in a central location in Colorado. Tentative dates will be in May or June of 2013. If approved Judie Moser will be the instructor with Barb Harris as her assistant.

We have checked with the Judges Committee and confirmed that she has six years experience and will be sending that Committee the information needed to update her file regarding the other criteria (number of shows, etc.) Having two performance judges will make those classes go faster and be a benefit to the exhibitors.

The cost would only be her \$300 fee for one day and a meal or two on the day she judges. She will be attending the show anyway, so will pay for her own hotel and travel expenses. To avoid even the appearance of a conflict I would request that the show schedule be adjusted so that all of the halter classes be completed before the performance classes begin. That way there will be no reason for the two judges to have any conversations before the halter classes.

It turned out that the cost of the facility is going to be much less than estimated in the original proposal approved by the Board at its March 13 meeting. At that time the cost was projected to be approximately \$1,466. When Joy drove up to Red Bluff, she was able to book a different part of the Fairgrounds which will only cost about \$750. With the money saved on the facility, there should be more than enough to cover the cost of a second judge.

This letter serves to inform you that the ALSA Board of Directors has taken additional disciplinary action as results of an Ethics Committee investigation concerning the posting of ALSA information on the SSLA website. At this time the ALSA Board of Directors has suspended your ALSA membership for a period of two (2) years effective June 12, 2012. During this two year period you must follow all rules of suspension per the ALSA 17th Edition Handbook; Part V; Section 2: A-3b and A-3c copied below.

- b. Suspension of such persons for any period from showing or having others show, exhibit or train for that person. A suspended person is forbidden for the time specified in the sentence to hold or exercise office in ALSA or any Sanctioned Show, from privilege of taking any part whatsoever in any Sanctioned Show, and is excluded from all show grounds during Sanctioned Shows, as an exhibitor, participant or spectator.
- c. Suspension of any llama(s) or alpaca(s), completely or part owned, of such a person at the time of the alleged violation. The Protest Committee or Board of Directors may at a later date remove the suspension of said llama(s) or alpaca(s) if a sale thereof is made in such a manner as to be a bona fide

transaction and not with the intention of relieving the suspended owner of penalty.

This suspension should serve as a strong warning that your conduct will continue to be monitored and that another incident involving ALSA Rules will result in more severe disciplinary action, up to and including your ALSA membership being revoked.

ALSA BOD Meeting Date: June 11, 2012

Dear ALSA Board of Directors,

The Llama Fleece Committee would like to make the following recommendations:

1. In an effort to clarify confusion regarding points awarded for llama fleece, page 33 of the new handbook (35/188 of the online document toolbar), D. 4 states: There are no points recorded for Champion and Reserve Champion at Halter, Performance Cart Driving, or Fiber. These achievements are recognized under ALSA Champion and Elite Champion Awards. (per Robin Turell at the ALSA Office, "Halter" should not be here. Grand & Reserve Champions in the Halter division are awarded points; Performance divisions are not awarded points).

INCORRECT: PERFORMANCE POINTS ARE AWARDED -BOD The "Points Chart" (187/188 of the online document toolbar) does not exempt any Champions/Reserve divisions and therefore it could be interpreted that animals earning a Grand and/or Reserve Champion will receive points based upon their division and not just their class. Additionally, Section O, 3, h (pg 100, 102/188 of the online document toolbar) states: Grand Champion and Reserve Grand Champion points will be given in each fiber division, Double, Single and Suri. The champions will be decided by the highest points scored on the fiber score card. In case of a tie, the judge will determine which criteria to use to break the tie. All of that being said, it is our recommendation that ALSA Points are awarded the any Grand and/or Reserve Fiber Champion and that everything should be tabulated as it is for Halter divisions.

2. Pursuant to Item 1, we recommend the word "fiber" from page 33 D4 for the 2013 18th Edition of the ALSA Handbook.

BOD accepted changes for 1 and 2 HANDBOOK CHANGES

3. Pursuant to Item 1, we recommend that ALSA eliminate the ALSA Fleece ROM and ALSA Fleece Champion and replace these awards with ALSA Walking Fleece ROM, ALSA Shorn Fleece ROM, ALSA Walking Fleece Champion and ALSA Shorn Fleece Champion (tabulated via the results of each divisions classes). We believe that the addition of separate lifetime fleece championships will encourage participation and add clarity to the ALSA Fleece Championship status.

BOD needs more clarification of criteria for each section.

- 1. Updating the ALSA Fleece Scorecards with the updated ALSA logo and reorganizing the placement of criteria so that "Cleanliness & Preparation" are at the bottom;

For instance, the ALSA office stopped sending show packets to superintendents several years ago, so all references to forms being included in show packets were changed to say the forms are available on the website or from the committee chairperson. As per Standing Rules Article I- ALSA Board of Directors Section 6: BOD Conduct:

a). Items of expected behaviors of BOD member are: respect, confidentiality, responsibility of a timely response, opportunity of opinion on all issues, avoidance of conflict of interest.

Since Ken Forster- President of ALSA Board of Directors allowed a motion that completely breaks the ALSA Bylaws, and allowed a vote of said proposal, he is in violation of conflict of interest, since he is not only a previous Board member, but a current "Alternate", which would not be seated until the new board voted on a proposal to fill those vacancies.

Larry Lewellyn voted on this motion that clearly had his interest, since he was also an "Alternate" of the 2012 election and would not be seated until the new board voted on a proposal to fill the vacancies.

By sanctioning Ken Forster and Larry Lewellyn, this would make them ineligible to take office on the 2012 ALSA Board or even be alternates.

Each board member that voted on the improper proposal is in violation of the ALSA Bylaws and should be sanctioned for such. If this means the 3-new board members come on to the ALSA Board of Directors and hold a special election to fill the 2-open slots, so be it. There has been a precedence of a special election in the past, so this is not unheard of. (September 2004, contact Jeff Jones- President of ALSA.) This Board is in complete ethics violation and should be punished to more than the average member; since they are suppose to be the people that follow the rules to the letter of our ALSA Bylaws, Standing Rules and Rule Book.

Dear Board Members.

I apologize for sending this month's report in at the last minute and am sending it directly to all of you so Kitty does not have to rush to do so.

The Rocky Mountain Regional Championship held on Labor Day weekend was a great success. I don't have the exact entry numbers or financial information yet, but it appeared that several of the classes were bigger than last year and everyone seemed to have a good time. The Get of Sire class was the biggest seen in the Region for many years. The potluck dinner on Saturday was a great opportunity to socialize and relax with old and new friends from several states, while the Llofty Llamas 4-H Club concession stand provided delicious breakfasts and lunches on both days. The only negative aspect of the weekend was that Bob Welsh was in the hospital recovering from heart surgery and had to miss the event for the first time. We all missed seeing Bob and sent him our best wishes for a speedy recovery. Barb Harris did a truly amazing job serving as superintendent during what had to be a very stressful time for her.

One of the Regional Superintendents has brought up a good point regarding an apparent inconsistency in the Regional Superintendent Guidelines. Paragraph 1 of the Guidelines specifically prohibits superintendents from paying the show clerk for a motel room or other expenses, but paragraph 2 allows payment for building and transporting obstacles. This seems unfair since the job of the show clerk is equally important and requires someone who can stay on duty throughout the entire show. Volunteers are the most precious asset we have and are becoming increasingly scarce, so we have to treat them all fairly. It isn't always possible to find a local volunteer to serve as show clerk and it isn't reasonable to ask someone to travel from out of town and not even reimburse any of their expenses. A solution to this problem would be to allow the Regional Superintendents more flexibility in how they use their \$500 seed money and not prohibit them from reimbursing the clerks for travel expenses as long as they provide adequate documentation of the expenses with their accountings. If the Board is amenable to this idea, we request that an exception to paragraph 1 of the Guidelines be approved for this year in case it is necessary for a Regional Superintendent to reimburse travel expenses for a show clerk.

We will also submit another draft revision to the Guidelines as soon as possible for your consideration.

- 1. CEC's for Fleece Judges: In addition to being active within the camelid community (superintending shows, writing articles, teaching, etc.), we believe that a Fleece Judge should judge a minimum of 50 fleeces within a 3-year period.
- 2. Fleece Judges who are recertifying: Create a one day seminar/workshop to be held regionally at minimum expense to participants (\$50/person maximum). This event would be taught by certified ALSA Instructors and would use a round table discussion format. The goal would be to open lines of communication, to discuss the issues of the day and to work toward consistent judging among all ALSA fleece judges.

ALSA Judges' Committee Report

December 2012

The Judges' committee has worked with the Fleece committee and the Alpaca committee to bring all ALSA judges to common criteria. Those committees have provided a lot of input and we are all pleased to announce that effective January 1st, 2013 there will no longer be Level and Senior designations for Fleece and Alpaca judges. Judges with over 5 years of experience from their Advanced clinic will be designated by asterisks next to their name. Fleece and Alpaca judges with over 5 years experience will be allowed to accept apprentices, become an instructor and judge Regionals or Nationals.

Recertification through CEC credits for Fleece and Alpaca judges is still being worked out and the Fleece, Alpaca and Judges committees hope to have an announcement regarding these sometime after the first of the year.

The committee asked for an exemption in August while we addressed the following inconsistencies found in the handbook:

Motion by Allen: that effective January 1st, 2013 there will no longer be Level and Senior designations for Fleece and Alpaca judges. Judges with over 5 years of experience from their Advanced clinic will be designated by asterisks next to their name. Fleece and Alpaca judges with over 5 years experience will be allowed to accept apprentices, become an instructor and judge Regionals or Nationals.

Chapter C Section 1

I. No llama or alpaca owned, co-owned or leased by the Halter Judge, Apprentice Judge or immediate family of these judges for the show, may be exhibited in halter classes, but may be entered in other divisions. The ALSA Judges' Committee has been reviewing the committee's original recommendation and subsequent board's decision regarding the disciplinary action for Cathie Kindler.

At this time the Judges' Committee would like to present to the board a proposal that is more in line with the original complaints that were filled.

We support the board's decision in the suspension of Ms Kindler but would like to request that board reevaluate the requirement as posted in the minutes dated June 14, 2011 that Ms Kindler be required to attend an Advanced Judging Clinic. The committee did not feel at the time of our report that Ms Kindler's performance as a judge was in question but her demeanor as an instructor was our concern.

It is therefore our request that rather than requiring Ms Kindler having to attend an Advanced Judging clinic at the end of her suspension in order to resume her judging duties that instead if she is wishing to continue as an instructor she be required to reenter the Instructor program. This would mean that she would be required to be an assistant instructor at a minimum of two Judging clinics and a favorable evaluation by the Lead Instructor at all said clinics.

If the board agrees that this is more in line with the original complaints against Ms Kindler we would like to further request that this modification be submitted in writing through a certified letter to Ms Kindler.
